VOLUNTEER RELEASE OF LIABILITY

READ CAREFULLY- THIS AFFECTS YOUR LEGAL RIGHTS

I, _____ hereby release, indemnify, and hold harmless the iCurea Foundation and their respective and all persons conducting directly, indirectly, demands, actions, causes of action, expenses or damages, which I or my heirs, personal representative, successors, assigns or anyone claiming by, through or under me ever had, now have, or may have against the parties identified above arising from any injury, act or omission relating in the way to my participation as a volunteer

- 1. AGREEMENT TO FOLLOW DIRECTIONS:** I agree to observe and obey all posted rules and warnings and further agree to follow any oral instructions or directions given by iCurea Foundation, or the employees, representatives, or agents of iCurea Foundation.
- 2. ASSUMPTION OF THE RISKS AND RELEASE:** I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge iCurea Foundation for injury, loss or damaged arising out of my or my family's use of or presence upon the facilities of iCurea Foundation, whether caused by the fault of myself, my family, iCurea Foundation or other third parties.
- 3. INDEMNIFICATION:** I agree to indemnify and defend iCurea Foundation against all claims caused of action, damages, judgements, cost of expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use or presence upon the facilities of iCurea Foundation.
- 4. FEES:** I agree to pay for all damage to the facilities of iCurea Foundation caused by any negligent, reckless, or willful actions by me or my family.
- 5. APPLICABLE LAW:** Any legal or equitable claim that may arise from participation in the above shall be resolved under Texas law.
- 6. NO DURESS:** I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement If I so desire.
- 7. ARM'S LENGTH AGREEMENT:** This agreement and each of its terms are the product of an arm's length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision given rise to such ambiguity.
- 8. ENFORCEABILITY:** The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be part of this Agreement.
